20/200 Apologies for Absence

None required.

20/201 Declaration of Interests and Requests for Dispensation

No interests were declared and no request for dispensation had been received.

20/202 Minutes of Meeting held on 12th November 2020

The minutes of the meeting were approved by the councillors who resolved that the minutes should be digitally signed by the Chairman as a correct record.

20/204 Public Forum

Four residents gave their views to the councillors on Item 20/206c. One was against the proposal, one supported the proposal and the two applicants gave the background and financial constraints that made approval of the application vital for the future of The Brewers Arms. The councillors thanked the owner of The Brewers Arms for the input he has given PPC on the proposed development over the past couple of months.

20/205 Emails circulated

Following a review of the emails circulated by the Clerk since the last meeting, the councillors resolved that a red litter bin replace the broken bin by the pond.

20/206 Planning

- a. The councillors reviewed Planning Application DC/20/03051 Prospect House, Stackwood Road - Erection of a single storey detached dwelling and garage (following demolition of existing outbuildings and garage) together with improvement to the vehicular access and resolved that they objected to the application on the following grounds:
 - i. The proposed dwelling is outside the BUAB
 - ii. In line with Babergh's Core Strategy policies, Polstead Parish Council has consistently objected to development outside the BUAB and this proposal does not offer any benefits to make the councillors deviate from this policy.
- b. The councillors reviewed Planning Application DC/20/05193 Treetops, White Street Green
 Conversion of part of cart lodge to form a bedroom and ensuite. Erection of a swimming pool and pool building and resolved to support the application.
- c. The councillors reviewed Planning Application DC/20/04417 Land Adjacent The Brewers Arms, Bower House Tye Change of use of land for the erection of 6no. dwellings and the siting of 5no. holiday cabins including creation of car park and alterations to existing vehicular access. The councillors discussed the application in the context of the development being outside the BUAB, the need for 6 dwellings to be built to support the creation of 5 holiday homes and the financial viability of The Brewers Arms following the impact of COVID-19. The majority of councillors felt that the need to develop 6 dwellings outside the BUAB for the scheme to proceed was not sustainable and was contrary to the council's policy of development outside the BUAB. However, the possibility that The Brewers Arms may fold, with the loss of a community hub that offers employment to local residents was not a risk that

the councillors were prepared to take. By a majority, the councillors resolved that they had no objections to the application.

- d. The councillors reviewed **Planning Application DC/20/05258 Bower House Farm, Bower House Tye** Change of use of land for the stationing of 2no shepherds huts for the provision of short term holiday let accommodation and resolved to support the application.
- e. The councillors reviewed **Planning Application DC/20/05210 Wannock, Hadleigh Heath** Erection of a single storey rear extension (following demolition of conservatory) and resolved to support the application.
- f. There was no further planning application received since the agenda was posted requiring a response before the next meeting.
- g. The councillors reviewed the status of planning applications, enforcement referrals and appeals previously reviewed by PPC as per Appendix A.
