- Suffolk County Council is on course to plant 200,000 trees across Suffolk as part of the 2020 fund to protect and encourage biodiversity within the county.
- Discussion is ongoing with the head of highways after a parishioner requested a traffic survey of Heath Road with a view to installing passing places. Cllr Hall was requested to liaise regarding the results of the survey prior to undertaking any work.
